

A Message From Our 1st Vice President Hal Roller

I Remember Some Thoughts from First Vice President Hal Roller

Remember back in the early 1970s when you heard the phrase MIA / POW a lot? My memory was jogged by a resent email Leigh Blood sent me. Leigh is on the emailing list of the American Legion, Georgia, POW / MIA Committee Chairman. This committee is dedicated to tracking down the identification and repatriation of MIA / POW / KIA soldiers. Leigh's email to me highlighted one name in particular. Staff Sergeant Casmir P. Lobacz of the 5th Infantry Division was reported missing on September 27, 1944 near Metz, France. If you recall, this timeframe was during World War II. The 5th Division had just completed a dash across central France under General Patton's Third Army. Everything halted before advancing into Germany because all supplies were diverted to Northern Europe for Field Marshal Montgomery's Allied Army Group. The soldiers of the 5th Division along with Third Army and all of General Bradley's American Army Group remained in place (while, of course, the German's prepared their defensive positions). This week, the Department of Defense POW / MIA Accounting Agency announced Staff Sergeant Lobacz's remains have been accounted for on March 2, 2022.

Reading this, I was struck by the vast effort and resources the United States puts into locating, identifying and repatriating MIA / POW / KIA. This has not always been so. Historically there were efforts made, but not many resources (including administrative work) were available. Often after combat, the dead were buried where they lay. Battlefield cemeteries grew in number during the Civil War as casualties reached the thousands. The best that was hoped for in notification was publishing a list of names in the local paper. Remember the scene in the movie Gone With the Wind when no one knew if he was dead or alive until "Ashley" came walking down the road home? This is what it was like. As time moved on, notification became possible with the telegraph. Even during World War II, as with Staff Sergeant Lobacz, things were difficult. On D Day +1 (June 7, 1944), the 82nd Airborne Division Commander ordered his chaplain to seek out and bury any dead paratroopers still hanging in trees. The Division Chaplain and his Chaplain Assistant would cut the paratrooper down, bury him in a shallow grave, conduct a very short memorial service, mark the grave site on a map, and move on to the next paratrooper.

What has remined constant throughout American military history has been remembering. The KIA is not just left where he fell. The MIA continues to be sought. The POW is ransomed. Certainly this brings comfort and closure to families. At the heart of it, however, is the ultimate worth of the individual. In America, every person is important. The soldier is not just an instrument for the state to achieve a military objective as practiced by some nations. The World War II Soviet Marshal Zhukov infamously stated he advanced infantry through a known minefield to clear it. Some say the American concept of remembering the MIA / POW / KIA is rooted in our national founding and the Enlightenment. It is deeper than that. It is based on the Christian worth of every person before God as stated in the familiar biblical verse John 3:16. It makes me proud to say with you and all Americans: I remember.

A Message From Our National Chaplain Ron VanBeek

Christian - God Confounding earth's Languages at Babel

Genesis 11:1 – And the whole earth was of one language, and of one speech.

It is hard to believe when we look at the over 20,000 different languages spoke on earth, that we all once spoke just one language. God instantly changed this reality, to accomplish His Grand Master Blue Print, that all the people of earth would occupy all the 197 countries, and a Christian church would be established in each country.

Now, God created our entire universe from nothing. He simply spoke and immediately our whole universe in all of it's incredible complexities, came forth. How great, how high, how majestic, how omnipotent, He is. We read in Genesis 1;31, that everything was perfect, very good. Now obviously, something that is created so unfathomable, so complex, it's Creator must be a far greater, far more infinite, then the lowly finite thing, that he created. Thus humans, the crownpiece of creation, created so unfathomable holy and complex, yet finite, cannot begin to understand or define this great Creator, who designed and implemented everything, down to the lowest atom. We read in Genesis 11:1 - that all the earth at that time spoke one language. But we know when earth's people again rebelled against God, and conspired to stay put, in one place, God confounded their language and forced everyone to spread out over the face of the earth, in the 3 different directions, which He had decreed to Noah's 3 sons. To understand our text today He obviously Created the human voice box, and the tongue. What a simple but complex, feature is our voice box is. Our voice box is only two fleshly strings situated, in the back of our throat, connected to our tongue, where our brain can control our speech and articulate our thoughts across the full spectrum of speech, so incredibly well. What a miracle is our human voice box; which also so differentiates us from the animals. Obviously, Because God has created our voice box he has also created language for its use. He Created all the various components of language, all the nine parts of speech, or words whether they are nouns, pronouns, verbs, adjectives, adverbs, prepositions, conjunctions, determinates, or interjections. The study of language is called linguistics, and there are five components of oral language. First there are phonology, the rules for combining sounds, or the structuring of words. For example there are 44 phonemes in English, which are groups of letters representing sounds according to an alphabetic principle. Second there are semantics, which are the ways that language conveys meaning. Morphemes are the smallest unit of meaning combines. Third syntax, the rules of how morphemes are organized into sentences or a word order. Fourth, there are pragmatics, which are the contextualized purpose in speaking appropriately, in a fitting situation. Fifth, vocabulary, which is the simple knowledge of words and their meanings. Now we don't want to bore you with an English lesson but it's important to have those basic understanding to dissect our text this morning. The key take away I want you to remember is not only that Jesus created the voice box and the tongue, but he created all these complex components of language. Yes, obviously no one knew language better than Jesus, who had designed and created it; and therefore we must believe Him as he uses the full spectrum of language, to convey His Words on earth in Scripture.

For example, in language there are 11 different kinds of sarcasm. Let's look at how Jesus uses sarcasm in Scripture. When the apostles are sleeping, after Jesus had earnestly warned them to remain awake, and Judas was a few steps away, Jesus says to His apostles, sleep on now, see if you can sleep now, it's a form of sarcasm.

In Scripture, sometimes Jesus speaks literally, sometimes He speaks metaphorically, sometimes He speaks allegorically, sometimes He speaks mystically, sometimes He speaks in parables, with a hidden meaning. Jesus himself says that He spoke in parables, to actually hide the true meaning of His Words, from those whom he spoke it to, but refused to obey. Yes, look at what directions, He instructed to Isaiah in Isaiah 6;9. He said, go, and tell this people, hear ye indeed, but understand not; and see ye indeed, but perceive not. Make the heart of this people fat, and make their ears heavy, and shut their eyes; lest they see with their eyes, and hear with their ears, and understand with their heart, and convert, and be healed. Today, let us hear His Word, in every language, in every country, repent and worship Him with all of our heart, mind, body, soul and strength.

Wayne Edward Cumer, 78, of Cherry Valley, passed away unexpectedly on Friday June 10, 2022 at home. He was born on December 22, 1943 a son of the late John and Margaret Fee Cumer.

A 1961 graduate of the Union High School in Burgettstown, he was drafted into the United States Army in November 1966 serving in Vietnam as a Recon Specialist and was a member of the Society of the 5th Division. He was honorably discharged in March 1968 a recipient of the National Defense Service Medal. After retiring from US Steel, Mr. Cumer worked for General Electric from where he also retired as well as

working on his family farm his entire life.

Wayne was a parishioner of Our Lady of Lourdes Roman Catholic Church in Burgettstown and a member of the Slovan V.F.W., the Elks Lodge 1221 in Aliquippa and Chairman of the Smith Township Planning Commission. His wife, Janice Patton Cumer passed away in 2005.

He is survived by his sister Carol Kilcoyne and husband Jack; nephews Tim Froats, Ted Froats and wife Julie; his niece Julie Grabowski and husband James; his companion Darlene Kopp and her children and grandchildren; and his Goddaughter Andrea Alex and her husband David.

The Society's Executive Board unanimously approved the Proposed Amendment to Article III (Membership), Section A (Eligibility) of the Constitution during its bi-monthly Board Meeting held on Tuesday, March 22, 2022. The amendment proposal will be presented for final approval to the General Membership during the General Membership Meeting planned for Sunday, September 25, 2022.

SPECIAL NOTICE TO SOCIETY OF THE FIFTH DIVISION MEMBERSHIP

Amendment Proposal to Constitution of the Society of the Fifth Division, United Sates Army Appointment: The appointment of the Constitution Committee was made by National President Gary Haverman, during the bi-monthly Executive Board Zoom videoconference held on Tuesday, January 25, 2022. Members appointed include: National Judge Advocate Phil Maniscalco (Chairman), Past National President Robert Dudley (Committee Member), Past National President Lou Pepi (Committee Member), National Historian Roger Allen (Committee Member) and National Secretary Scott Murrah (Committee Member). Advising the Committee is National Treasurer George Shoener.

The Constitution Committee was directed to consider the request by National Secretary Scott Murrah to change the eligibility requirements to the Constitution to allow relatives of Society Members, who have served in the Armed Forces as war time veterans, to become voting members of the Society of the Fifth Division and to help grow the Membership in the Society.

The Committee presented its findings & recommendation to approve the change in voting member eligibility, to the Executive Board during the Executive Board Zoom videoconference held on Tuesday, March 22, 2022. The Executive Board approved the Proposed Changes by unanimous vote.

The proposed change will be presented for final approval to the General Membership at the General Membership Meeting planned for Sunday, September 25, 2022 during the Society's annual reunion and convention at the Oasis Conference Center, Springfield, Missouri.

Amendment Proposal to Constitution of the Society of the Fifth Division, United Sates Army Current Paragraph A. ELIGIBILITY of Article III. MEMBERSHIP reads...

Those who served honorably as officers and enlisted men in the Fifth Infantry Division during its periods of activation are eligible to become members of this Society.

Proposed Paragraph A. ELIGIBILITY of Article III. MEMBERSHIP to read...

Those who served honorably as officers and enlisted men and women in the United States Armed Forces in the Fifth Infantry Division during its periods of activation are eligible to become members of this Society.

Also eligible to become members of this Society are war veterans who served honorably as officers and enlisted men and women in the United States Armed Forces and who are ancestors (parent, grandparent, etc.), lineal descendants (child, stepchild, grandchild, etc.) or collateral descendants (brothers, sisters, nephews, nieces, etc.) of those who served in the Fifth Division. Also eligible are members of Regiments of the Fifth Infantry Division that remain active in the United States Armed Forces.

Background:

The Society of the Fifth Division, United States Army - Veterans of World Wars formed the Articles of Incorporation under the General Not for Profit Corporation Act in Springfield, Illinois on November 8, 1952 in perpetuity.

An excerpt from a letter dated September 7, 2008 from the Department of the Treasury (IRS) addressed to Society of the Fifth Division c/o Donald B Smallwood (Society's National Treasurer) "recognized that the Society is exempt from federal income taxes under section 501 (c)(4) of the Internal Revenue Code. This determination is based on the Society's representation that at least 90% of its members are past or present members of the Armed Forces of the United States defined under section 501 (c)(19) of the Code. Based on the Society's representation that at least 90 percent of its members are war veterans and that it is organized and operated primarily for the purposes consistent with its current status as a war veterans' organization, donors can deduct contributions made to or for the use of the organization".

Research and Findings:

Before the enactment of IRC 501(c)(19) on August 29, 1972 (Public Law 92-418, 86 Stat. 656, reproduced in 1972-2 C.B. 675), war veterans' organizations were grouped together with all other veterans' organizations and recognized as exempt under IRC 501(c)(4) as social welfare organizations.

Since IRC 501(c)(19) organizations may conduct a broad range of activities without jeopardizing their tax-exempt status, many veterans' organizations are organized under this authorization. However, there is a requirement that at least 75 percent of the members must be past or present members of the US Armed Forces. Because the ranks of war veterans were thinning, and many organizations were at risk of losing their tax-exempt status due to waning membership, Congress amended IRC 501(c)(19) on September 3, 1982 (Public Law 97-248, 96 Stat. 640), by deleting the requirement that 75 percent of the members be war veterans. War veterans' organizations are described in IRC 170(c)(3).

Congress relaxed membership requirements again in 2003 with passage of Section 105 of the Military Family Tax Relief Act by permitting veterans' organizations to count ancestors and lineal descendants as part of their veteran base. The Act also broadened the purposes of veterans' organizations.

Since the Society of the Fifth Division is organized as an IRC 501(c)(4) organization, unlike an IRC 501(c)(19) organization that has specific membership requirement, there is no membership requirement to maintain our tax-exempt status. However, in order for donors to deduct contributions from their income tax, the Society must be 90 percent war veterans.

Recommend:

Given that the Constitution Committee's objectives are to grow the war veteran membership, remain an IRC 501 (c)(4) organization, be eligible to receive tax-deductible contributions under IRC 170 (c)(3) by having at least 90 percent of the members be war veterans and allowing war veteran family members to be eligible to become Society members, the change to the wording in the Constitution's Membership (Article III), Eligibility (Section A) is recommended.

Greetings All,

We who served in Vietnam were effected from it in many different ways: even to this day.

Over this past Memorial Day Weekend, I got an email from a family member thanking me for leaving a comment on the "Vietnam Wall of Faces" for James George Howard, KIA, Quang Tri Province, June 1, 1970. It had been 52 years since the HHC Security Platoon Leader Lt. Howard, Platoon Sargent Sgt Mossner, and Squad Leader Sargent Auldon were killed by IED. The previous Security Platoon Sargent Issac was killed by an IED a few days earlier. Squad Leader Sargent Gliemmo witnessed both IED events which was close to the northwest side of Quang Tri Combat Base. I knew all four KIA's, and Jim Howard who was a friend when I was with Brigade HHC before my next assignment as the Graves Registration Officer. I cannot express talking to Jim's family and their kind words has helped me. Once our Fallen starts their way back home, there is little information provided to Families or the Soldiers who were affected by the death.

While Bob Gliemmo and I were providing additional information relating to Jim's death, leadership, comrade with others, we both were overwhelmed with gratitude. We were helping Don, Sharon, and Pam find some peace and closure; it was heart wrenching to hear how little they were told and how difficult it has been for them to find out what actually happened.

My weekend began with an exchange between myself and the Howard Family. Below you will find a selection of emails in chronological order from top down and a beautiful poem written from a young family member years later. It was definitely a WOW!

Thank you for your comments on the Wall of Faces. We have often wondered about other soldiers that might have memories of Jimmy. We would love to have you share your memories of him or your times in Viet Nam. Perhaps you know others that returned from their service there.

We just returned from Washington DC and visited the Wall Memorial monument. We have taken 5 of our 7 grandchildren and will take the last two, twins when they reach 10 yrs old. One of the twins is James and he reminds us of Jimmy.

Please accept our deepest gratitude for the service that you gave for us and our country. It is unimaginable what the sacrifices have been for the soldiers and their families.

First Memorial Day Weekend I had something to smile about! Same for today, knowing I have done everything I could do for Jim. Thank you so much!

I wasn't Jim's best friend, I was a friend though, and I'm sure there's many other Vietnam friends too who knew Jim; I am just one who has spoken out.

I don't have everyone's email address; Don & Sharon, feel free to send me your email addresses if you like.

I hope you talked to Bob Gliemmo; and it helped to know everything about what occurred to Jimmy, 52 years ago on this day.

A lot has happened for you all, in a good way this past weekend, in thinking of Jimmy's death. I can't imagine how difficult this has been for you all these decades, to know little about Jim and Vietnam; then suddenly there is more information than you ever thought you would ever know.

You are part of the Fifth Division Family. If you look up The Society of the Fifth Division web site, you will read all about our Fifth Division as it has a long past History. Even to this day, one of its Battalion's from Vietnam has been involved with the training of new Army Recruits at Ft Jackson, South Carolina.

I would like to write an Article to the Red Diamond about what happened to us this past Memorial Day Weekend. I will say nothing negative as to certain individuals we talked about. You are and will always be part of the Fifth Division Family.

You are also, and will always be, part of the Gold Star Family's; I encourage you, if you haven't done so, please contact your local area Gold Star Family Association.

Jerry, this is Don Howard.. Words can't express how thankful all of us are to have discovered you and Bob. Yes, you have our approval to write as you wish.. These last few days have been so incredibly important to us - we will never forget it. We are forever indebted to the two of you.. Keep us in the loop, and look forward to meeting you in the future.

Don & Sharon,

I talked to Bob Gliemmo tonight. We find many times we were in some of the same areas, so we discuss our experiences from different perspectives. It's amazing for us that after 52 years later the amount of details we remember about being in some of those same locations, but with different Missions. Bob told me tonight he had a good phone conversation with Sharon as she had a lot of questions to ask. Bob is full of knowledge as to the Security Platoon and the time Jim was there.

I would like to provide other information as to where the Security Platoon resided within the Brigade and its Mission. I know Bob is providing you what Jim was doing as his Platoon Leader...

On an earlier conversation with both of you I said I talked to Jim a few days before he was killed, but Jim's Platoon Sergeant (SGT Issacs) was killed May 27th so I must have talked to him May 28 or 29. Sgt Issacs didn't come to Quang Tri Graves Registration . He was medivac out to the Hospital Ship off coast since he had a very serious head wound from an explosion. When I saw Jim we both knew Sgt Issacs died and of course was upset about it.. I know he told me he was being pushed hard by the Deputy Commanding Officer (DCO). That DCO replaced another DCO whose tour was over sometime in early February. I believe Bob said Jim started changing in Feb; I still believe he didn't help the situation. A couple days after Jim's death I went to the Headquarters Ceremony for Jim and the other three Security soldiers killed within that same week. I remember there were grumblings at that ceremony from others about the DCO aggressiveness.

This is a poem that my daughter, Sara, wrote in the 8th grade in 2000. Don and Pam had visited the Vietnam Veterans Memorial,

and she was touched hearing him explain his unexpected reaction to the memorial. She won 1st place in the D.A.R. poetry

We can't begin to express the gratitude we feel to you in answering questions that have tormented us since 1970.

However difficult it was to hear, we are immensely thankful to you for helping us find closure. You are friends that

we will forever treasure.

Standing at the wall There is an endless sea of names. The long black shiny wall Seems innocuous cut into the earth. From a distance, it blends innocently Into the majestic landscape. Jerry and Joy,


Thank you for your constant support. Somehow Don & I can't help but think that Jimmy had a hand in our connecting with you. For us, it has been a blessing.

VA proposes updates to disability rating schedule



■ The Department of Veterans Affairs has proposed changes to the VA Schedule for Rating Disabilities that pertain to the respiratory and auditory systems. The changes will incorporate medical advancements for treating certain disabilities and modern medical knowledge to more accurately compensate veterans for their service-connected disabilities, according to the VA.

"Veterans who currently receive compensation for a service-connected condition in these body systems will not have their disability rating impacted when the VA Schedule for Rating Disabilities is updated," said Thomas Murphy, the acting undersecretary for benefits.

Some of the proposed changes include modernizing the evaluation criteria for sleep apnea by evaluating it

based on the symptoms' responsiveness to treatment. If symptoms are fully treated with a CPAP machine or other treatment, a veteran would be rated at 0% and not receive compensation; the VA will award progressively higher percentage evaluations based on how symptomatic the condition remains after treatment.

In public comments, DAV stated that the proposed change is a failure to "address the functional impairment caused by sleep apnea" and asserted that the current 50% rating is appropriate.

For tinnitus (ringing in the ears), proposed changes would recognize that symptom as part of a veteran's broader ailment. The veteran would receive service-connected compensation for tinnitus through the disease to which it is attributed, rather than as a stand-alone disability.

DAV also opposes this change, noting the proposal contradicts a legal precedent decided in 1994 that said veterans are entitled to separate evaluations and distinct ratings—for conditions that stem from a single disability if they are not duplicative.

"No change to a veteran's current rating would automatically occur due to these proposed changes," said National Service Director Jim Marszalek. "When and if the proposed changes are finalized, veterans should seek assistance from a veterans service organization like DAV before filing a claim for increase to determine the impact of the final rules."

VA shares implementation plan and locations of PAWS Act pilot program

The Department of Veterans Affairs has announced its plan for implementing the pilot program required by the Puppies Assisting Wounded Servicemembers (PAWS) for Veterans Therapy Act.

The PAWS Act, signed into law Aug. 25, 2021, requires the VA to conduct a five-year pilot program to provide canine training as an element of a complementary and integrative health program for eligible veterans diagnosed with post-traumatic stress disorder.

Veterans participating in the program will have

the opportunity to train potential future service dogs, with the goal of helping veterans manage their PTSD symptoms.

The pilot program will be offered at VA medical centers in Anchorage, Alaska; Asheville, North Carolina; Palo Alto, California; San Antonio, Texas; and West Palm Beach, Florida.

Clinicians at the pilot sites will determine the eligibility of veterans interested in the pilot program. Agreements with the participating organizations that will furnish the training have not been finalized.

VA May Have to Report on Health Care Records Program

A new bill could require VA to submit quarterly reports to the Senate. The bill aims to increase the transparency of the VA's implementation of the new electronic records program.

he House and Senate in May passed a bill that could require VA to submit five quarterly reports to Congress regarding the status of the Electronic Health Record Modernization Program.

In May, the Senate approved the VA Electronic Health Record Transparency Act of 2021 (H.R. 4591). The bill passed the House last November, where originally it was introduced. The bill would require VA to regularly report on the status of the new health care record system, including problems with its implementation. The new medical record system is planned to be fully rolled out at VA medical facilities by 2028.

The new electronic records system will give VA easier access to the Department of Defense's health records. The VA Electronic Health Record Transparency Act, as of the magazine's print deadline, has not been signed into law by President Joe Biden. If approved, the VA Electronic Health Record Transparency Act would require VA to give a report within 90 days of the bill's approval date.

In March, VA Inspector General Michael Missa reported that his office received "wide-ranging com-

plaints" to VA's hotline about the Mann-Grandstaff VA Medical Center in Spokane, Wash. Members of Congress also have expressed concerns since the Cerner Corporation's VA Electronic Health Record launch of a pilot program at the VA medical facility in 2020.

"Our oversight work is vital given the potential impact of this new system on patient safety and the quality of health care provided to veterans, as well as its costs," Missa said. "A number of those complaints and the failings specifically found [were] with respect to medication management, care coordination and the ticketing process for staff to request and report problems." Missa added that reports from the VA's Inspector General's office addressed many of those allegations.

The VA in 2018 signed a contract with Cerner, a North Kansa City, Mo.based medical information technology company, to overtake VA's health record system and make it compatible with DoD's record system.

VFW Continues to Advocate for the PACT Act

The passage and signing of the Honoring Our Promise to Address Comprehensive Toxics Act of 2022, also known as the Honoring Our PACT Act, has continued to be one of VFW's high priorities.

Over the last year, VFW has urged members of the Senate to pass the bill, which would then head to President Joe Biden's desk for approval. The Senate had not approved the *PACT Act* as of *VFW* magazine's August issue print deadline.

Then-VFW Commander-in-Chief Matthew M. "Fritz" Mihelcic spoke on May 28 about the *Honoring our PACT Act* during the Rolling to Remember rally in Washington, D.C. There, Mihelcic asked those attending to contact their senators about supporting the "historic" and "comprehensive" bill.

"The time is now to get this done; no more delays," Mihelcic said at the rally.

VFW believes the *Honoring Our* PACT Act is the most significant legislation for veterans in history. The bill aims

to address a range of issues dealing with toxic exposure.

If passed by the Senate and signed into law, *H.R. 3967* will:

- Add 23 respiratory illnesses and cancers related to burn pits and airborne hazards exposure as presumptive conditions.
- Add hypertension and monoclonal gammopathy of undetermined significance to the VA's list of presumptive conditions of Agent Orange exposure.
- Add Thailand, Laos and Cambodia to locations where Vietnam War veterans had a presumptive exposure to Agent Orange.
- Require VA to provide training to improve toxic exposure disability claims.
- Require VA to conduct outreach campaigns and provide resources to veterans exposed to toxins during military service.

New VA Benefit Gives Guaranteed Life Insurance

Starting in January 2023, VA-rated disabled veterans with a 0 to 100 percent rating — will be eligible to purchase guaranteed life insurance.

The new life insurance benefit Veterans Affairs Life Insurance, or VALife, will be available to disabled veterans younger than 81 years old. Some veterans who are older also might be eligible, according to a VA press release.

VALife will give an option of life insurance for veterans who may not have qualified for insurance in the past. The new program was created through the passage of the Johnny Isakson and David P. Roe, M.D. Veterans Health Care and Benefits Improvement Act of 2020, or P.L. 116-315.

The new service, according to VA, will feature a way to enroll online. VA also claims insurance approvals will be "instant." Also, there will be "no medical requirements" to participate in the new service.

Expanding VA dental care

DAV-backed Senate bill would ensure all enrolled veterans receive dental benefits

ust 15% of the more than 9 million veterans enrolled in Department of Veterans Affairs health care are eligible for dental benefits. However, the number of veterans actually receiving VA dental care is much lower—about 463,000—according to senators supporting legislation that would significantly increase access.

The Veterans Dental Care Eligibility Expansion and Enhancement Act of 2021 (S. 3017) would remove the current barriers to VA dental care by broadening eligibility for all veterans enrolled in VA health care. The bill also seeks to address the shortage of dentists by providing incentives to dental school students and mandates the expansion of VA dental clinics in all 50 states.

"As the former chair of the Senate Committee on Veterans' Affairs, I have seen up close the pain, death and despair caused by war and its aftermath," Sen. Bernie Sanders said when introducing the bill last October. "Honoring that extraordinary sacrifice and bravery is one of the most important commitments we have as a country. That means making sure our veterans and their families have access to the best and most comprehensive health care, including dental care, our country can provide."

Right now, to receive VA dental benefits, veterans must have a service-connected dental disability or condition they receive compensation for; be a former prisoner of war; have a noncompensable serviceconnected dental disability caused by combat or service trauma; have a dental condition verified by the VA as aggravating a service-connected disability; be rated 100% disabled or rated for Individual Unemployability; be receiving Chapter 31 educational benefits; or require dental care due to a condition being treated through inpatient VA care.

"Today, dental care is not treated like the vital health care it is, and only a small fraction of veterans are eligible to receive dental care through the VA because of stringent eligibility requirements," added Sen. Kirsten Gillibrand. "This bill would help eliminate eligibility restrictions and make dental care more affordable and accessible to all veterans."

Research has linked gum disease to several chronic conditions affecting veterans, such as diabetes, heart disease and stroke.

DAV supports S. 3017, in accordance with DAV Resolution No. 18, which recognizes the importance of oral health as a basic need for veterans and calls on the VA to expand dental care for all veterans.

The leadership of the Senate Veterans' Affairs Committee held a roundtable on VA dental care in April, which DAV took part in.

"Dental care is an integral part of an individual's overall health, and we should treat it as such," said National Legislative Director Joy Ilem. "Right now, there are too many limitations that prevent veterans from obtaining this essential benefit that we believe should be part of VA's 'whole health' approach, so we greatly appreciate the opportunity to have this discussion and highlight this important issue."

Morrill Worcester, owner of Worcester Wreath Company of Harrington, Maine, was a 12-year-old paperboy for the Bangor Daily News when he won a trip to Washington, D.C. His first trip to our nation's capital was one he would never forget, and Arlington National Cemetery made an especially indelible impression on him. This experience followed him throughout his life and successful career in business, reminding him that his good fortune was due, in large part, to the values of this nation and the veterans who made the ultimate sacrifice for their country.

In 1992, Morrill found himself with a surplus of wreaths nearing the end of the holiday season. Remembering his boyhood experience at Arlington, Worcester realized he had an opportunity to honor our county's veterans. With the help of former Maine senator Olympia Snowe, arrangements were made for the wreaths to be placed at Arlington in one of the older sections of the cemetery – a section which had been receiving fewer visitors with each passing year.

As plans were underway, a number of other individuals and organizations stepped up to help. James Prout, owner of local trucking company Blue Bird Ranch, Inc., generously provided transportation all the way to Virginia. Volunteers from the local American Legion and VFW posts gathered with members of the community to decorate each wreath with traditional red, hand-tied bows. Members of the Maine State Society of Washington, D.C., helped to organize the wreathlaying, which included a special ceremony at the Tomb of the Unknown Soldier.

This act of generosity became an annual tribute that went on quietly for several years each December, led by Morrill and his family until 2005, when a photo of the stones at Arlington, adorned with wreaths and covered in snow, circulated around the internet. Suddenly, the project received national attention. Thousands of requests poured in from all over the country from people wanting to participate – to emulate the Arlington wreath project at their national and state cemeteries, or to simply share their stories and thank Morrill Worcester for honoring our nation's heroes.

Unable to donate thousands of wreaths to each state, Worcester began sending seven wreaths to every state, one for each branch of the military, and for POWs/MIAs.

In 2006, with the help of the Civil Air Patrol and other civic organizations, simultaneous wreath-laying ceremonies were held at over 150 locations around the country. The Patriot Guard Riders volunteered as escort for the wreaths going to Arlington. This began the annual "Veterans Honor Parade" that travels the East Coast in early December.

The annual trip to Arlington and the groups of volunteers eager to participate in Worcester's simple wreath-laying event grew each year until it became clear the desire to remember and honor our country's fallen heroes was bigger than Arlington, and bigger than this one company.

In 2007, the Worcester family, along with veterans and other groups and individuals who had helped with the annual veterans wreath ceremony in Arlington, formed Wreaths Across America (WAA), a nonprofit 501(c)(3) organization, to continue and expand this effort, and support other groups around the country who wanted to do the same. The mission of the group is simple: Remember. Honor. Teach.

In 2008, over 300 locations held wreath-laying ceremonies in every state, Puerto Rico and 24 overseas cemeteries. More than 100,000 wreaths were placed on veterans' graves. Over 60,000 volunteers participated, including members of national veterans' organizations and the American Gold Star Mothers.

December 13, 2008, was unanimously voted by the United States Congress as National Wreaths Across America Day.

In 2011, WAA and its national network of volunteers laid 325,000 veterans' wreaths at 750 locations in the United States and beyond. WAA was able to include ceremonies at the Pearl Harbor Memorial, as well as Bunker Hill, Valley Forge and the sites of the September 11, 2001 tragedies. WAA accomplished this with help from 902 fundraising groups, corporate contributions, and donations of trucking, shipping, and thousands of helping hands.

The wreath laying is still held annually on a Saturday, each December, and has expanded to include more than 3,100 locations and 2.4 million wreaths. And for the first time in 2018, our mission expanded overseas with the placement of 9,387 veterans' wreaths at Normandy-American Cemetery in France. Each wreath is placed by a volunteer and the names of our fallen said out loud to keep their memory alive.

Who We Are

Wreaths Across America (WAA) is a national nonprofit organization founded in 2007 to continue and expand the annual wreath-laying ceremony at Arlington National Cemetery begun by Maine businessman Morrill Worcester in 1992.

- ★ 1992: First wreaths (5,000) donated by Morrill Worcester and Worcester Wreath.
- ★ 2005: Iconic photo of wreaths in snow became a viral sensation.
- ★ 2007: Wreaths Across America formed as a 501(c)(3) nonprofit.
 - Organization governed by board of directors. Day-to-day operations managed by volunteer Executive Director Karen Worcester.
- ★ 2012: Millionth wreath placed at Arlington National Cemetery.
- ★ 2014: For the first time, every headstone at Arlington National Cemetery received a wreath.
- ★ 2016: 25th year that veterans' wreaths were placed at Arlington National Cemetery.
- ★ 2018: Mission advances overseas with the first placement of 9,387 veterans' wreaths at Normandy-American Cemetery in France.
- ★ 2021: Marked the 30th year that veterans' wreaths have been placed at Arlington National Cemetery, a tradition started by Maine wreathmaker Morrill Worcester as a gift of thanks.

WAA's mission – *Remember, Honor, Teach* – is carried out in part by coordinating wreath-laying ceremonies at Arlington, as well as at veterans' cemeteries and other locations in all 50 states.

Every year since 2008, Congress proclaims a Saturday in December as National Wreaths Across America Day. This year, it will be held on **Saturday, Dec. 17, 2022.**

2021 Recap

- ★ 2.4 million veterans' wreaths were placed in total across the country.
- ★ More than two million volunteers participated at 3,137 locations nationwide. More than a third of the volunteers were children.
- ★ At Arlington National Cemetery specifically, the Wreaths Across America program saw 66 tractor trailers deliver over 250,000 veterans' wreaths that were placed by nearly 38,000 volunteers.
- ★ Over 525 truckloads of wreaths were delivered across the country by hundreds of volunteer professional truck drivers driving donated equipment and fuel from approximately 390 carriers.

2022 Theme: Find a Way to Serve

The inspiration for this year's theme came from a few different places and seemed to be a recurring conversation throughout the last year. Notably, the **American Rosie Movement**TM which highlights the stories of the World War II-era women known as Rosie the Riveters, or simply "Rosies." These women pulled together to do the work that needed to be done for our freedom. The movement encourages youth to get involved in their own communities to serve in small ways that can make a big impact. As part of this new theme, Wreaths Across America is revamping its educational curriculum working with like-minded organizations to develop action plans to inspire young people across the country to find a way to serve in 2022 and beyond.

What We Do

REMEMBER

WAA's annual pilgrimage from Columbia Falls, Maine, to Arlington National Cemetery in Virginia has become known as the world's largest veterans' parade, stopping at schools, monuments, veterans' homes, and communities all along the way to remind people how important it is to Remember, Honor and Teach.

★ The Remembrance Tree Program provides a living memorial to loved ones lost. A replica dog tag is made in honor of your loved one and it is attached to the trunk of an evergreen tree on the tip land in Maine where the brush is harvested every third year to make veterans' wreaths.

★ The HART Ceremony (Honoring Allies and Remembering Together) is conducted each year to honor veterans of our nation's allies in ceremonies on international bordercrossing bridges between Calais, Maine and St. Stephen, New Brunswick, Canada; Detroit, Michigan and Windsor, Ontario, Canada; and Sweetwater, Montana and the Alaskan/Canadian border.

★ WAA hosts statehouse ceremonies in nearly 50 states.

HONOR

- ★ Through WAA's national group sponsorship program, it has helped other nonprofits and civic groups such as Civil Air Patrol, Scouts, 4- H Clubs, local VFWs and American Legions raise funds for their own community needs. Since 2007, Wreaths Across America has given back more than \$17 million to local groups.
- ★ WAA conducts several programs to honor our veterans, including our popular Thanks-A-Million campaign, which distributes free "I Owe You" cards to people all over the country to share with veterans as a simple thank-you for their service and a promise to give back.
- ★ The organization participates in veterans' events throughout the year as well as public outreach through Veterans Day and Memorial Day programs, Wreaths Across America Radio, in our monthly newsletters, in press coverage and on the website.
- ★ The Wreaths Across America Museum located at the National Headquarters in Columbia Falls, Maine, showcases thousands of items that have been donated to Wreaths Across America over the decades. All donations help to provide insight and tell the greater story of the experiences of U.S. military personnel.
- ★ Wreaths Across America has a veteran liaison on staff to work with local veterans' organizations in Maine.

- ★ WAA is committed to teaching younger generations about the value of their freedoms and the importance of honoring those who sacrificed so much to protect those freedoms. We offer learning tools, interactive-media projects and opportunities for schools, 4-H clubs, Scouts, and other youth groups to participate in our efforts.
- ★ The Mobile Education Exhibit is a traveling classroom on wheels designed to inspire and educate all about the mission and those who lives have been impacted by it. The goal of the Wreaths Across America Education Exhibit is to bring local communities and our military together with education, stories, and interactive connections.

Frequently Asked Questions

Why do you use live wreaths?

Wreaths Across America does not "decorate" headstones. We are honoring all veterans and active military members by placing live, balsam veterans' wreaths on the headstones of our nation's servicemembers. The fresh evergreens have been used for centuries as a symbol recognizing honor and as a living tribute renewed annually. We want people to see the tradition as a living memorial to veterans and their families.

Does WAA have a religious or political affiliation?

Wreaths Across America is not affiliated with any religion or political party. It is our mission to remember and honor every fallen military service member during the holiday season, no matter what is happening in the nation or overseas. These are not Christmas wreaths, they are veterans' wreaths or remembrance wreaths. Our goal as an organization is to Teach younger generations about the diversity of our American heritage, and the freedoms for which so much was sacrificed.

What are the sources of funding for WAA?

WAA receives no government funding. National Wreaths Across America Day and other events are made possible by thousands of volunteers who organize local ceremonies, raise funds to sponsor wreaths and participate in the events. Individual wreath sponsors and corporate donors, pay for most of the cost for the program and volunteer truck drivers and trucking companies make it possible for WAA to transport wreaths all over the country.


