



## A Sermon from our Chaplain Ron VanBeek

Chaplain Message - Christian Jewish - Yom Kippur

Yom Kippur is one of Israel's most sacred holidays. It is the Jewish day of repentance and/or resurrection to new life. While Yom Kippur is marked by fasting, before it begins a special festive meal is enjoyed. It's customary to set the home tables beautifully the way they would be for Shabbat or another holiday and to eat together with family or friends. This special afternoon meal before the fast begins, allows joyful celebrate of the holiday, as well as strengthening for the rigors of the fast to come. This meal – called seudah hamafseket, or meal of cessation in Hebrew – has to be concluded while it's still light outside, and should contain no alcohol, garlic or heavily spiced foods.

Many Jews wear white clothes like angels, fasting as if they were living entirely on a spiritual plane. For one day, they leave behind the physical and focus purely on their spiritual selves. On this holiest day, food and drink is given up. On this day Jews, also don't bath, anoint ourselves, wear leather shoes, or engage in marital relations. It's a day to downplay our physical needs and pleasures, and focus on each human's spiritual sides instead.

While Yom Kippur is a day of forgiveness, when it comes to atoning for bad things done to another person, it is required to reach out and apologize and seek forgiveness from those personally harmed. Sins between man and God can be atoned for through prayer and sincere teshuva, repentance, but If the pain caused another person can be remedied – for instance by paying to fix something we've broken – we have an obligation to do that too, before we can truly be forgiven.

Yom Kippur is closely connected to Purim, even though it seems to be the opposite: it's a joyous spring holiday marked by lots of spirited singing, dancing, giving presents, eating and drinking. Yom HaKippurim means both "Day of Atonement" and "a day like Purim". Both paths allow us to bring spirituality into our lives and elevate ourselves using radically different methods: Purim through engaging all our physical senses and Yom Kippur by denying and downgrading our physical sides.

While Jews generally do not kneel in the synagogue, on Yom Kippur and Rosh Hashanah it's customary to kneel at several key points in the service. This departure from ordinary custom underlines the specialness of this holy day and recalls the ancient service in our holy Temple in Jerusalem, when the Kohen Gadol, the High Priest, would prostrate himself during some points of the service.

The term "scapegoat" originates with the Yom Kippur service. In ancient times, the Kohen Gadol would take a goat and confess the sins of the entire people of Israel over it before driving it away into the desert and off a cliff (Leviticus 16:1-34). We read of this ancient ritual on Yom Kippur morning, as we pray that our sins will similarly be banished and forgotten today.

Starting the year with a clean slate, the evening after Yom Kippur is also considered a holiday. It's customary to eat a festive holiday meal and to wish each other holiday greetings. Many Jews recite a beautiful prayer over the new moon after Yom Kippur services, and Jews all over the world spend the evening preparing for the next big Jewish holiday: Sukkot, just four days away.

Families like August O'Niell's are filled with service members and veterans. He and his brother are Air Force pararescuemen, and his mom, dad, and stepdad are all Air Force veterans, so they understand the risk of getting the call that no one wants. In 2011 they received that call when August was shot in Afghanistan.

August spent the next three years attempting to rehabilitate his leg before opting for an amputation. From first being medically evacuated to Landstuhl, Germany through approximately 20 surgeries at hospitals in Maryland and Texas, his mother, brother, sisters, father, and stepfather all came to support him, usually staying at a nearby Fisher House.

Some families stay at a Fisher House for a couple of days while others stay multiple times for months or even years due to the severity of their loved one's injury or illness. For many, the need continues long after they leave service. #### FROM OUR CHAPLAIN

Arlington Funeral Message of Phillip Andrew Briggs

And The Voice Said, Cry. And Isaiah said, what shall I cry? The Voice said, Cry aloud, that All flesh is as the grass. The grass; withereth. The flower; fadeth. The Dust; returns to Dust, because the wages of sin is Death, and then man returns to his long home. The Spirit of The Lord bloweth upon it. But The Word of our God shall stand forever.

Today, we are gathered together on this hallowed ground, with the extended Briggs family, and his 5th Division brothers, to commit Phillip Andrew Brigg's final remains to the earth, from which it came. During the earlier funeral service his dedicated life to the welfare of his family, his church, and society was covered.

He was awarded two Purple Hearts, two Bronze Service Star Medals, and the Combat Infantryman Badge for his meritorious bravery in Vietnam as an Army Infantryman in 1970-71. His heroism and medals earned while serving near the

DM with the 5th Division in Vietnam has helped keep America Safe and Free. The 5th Division salutes him. America salutes him. As a fellow combat veteran in the 5th Division with him near the DMZ, I Salute him. Just read his many citations.

But today his life have been silenced, by the cold hand of death. However, God's Voice still Cries Aloud to us the living, as we stand here in this sacred cemetery, surrounded by the graves, standing in the midst of death. All around us the 1000s of graves and the stones testify to that bitter Reality, that death is the wages of sin, and that last enemy, Satan, still has the power of death.

The Voice Cries Aloud, that because of sin, we can not remain in this world for we are all born dead in sins and trespasses, sentenced to death. We know that God originally Created all mankind perfect in Eden, but in the

Isolated atrocities committed by American soldiers produced torrents of outrage from anti-war critics and the news media while Communist atrocities were so common that they received hardly any media mention at all. The United States sought to minimize and prevent attacks on civilians while North Vietnam made attacks on civilians a centerpiece of its strategy.
- 27. Americans who deliberately killed civilians received prison sentences while Communists who did so received commendations. From 1957 to 1973, the National Liberation Front assassinated 36,725 Vietnamese and abducted another 58,499. - #1. Myth: Common Belief is that most Vietnam veterans were drafted. Fact: 2/3 of the men who served in Vietnam were volunteers. 2/3 of the men who served in World War II were drafted. Approximately 70% of those killed in Vietnam were volunteers.
- #2. Myth: The media have reported that suicides among Vietnam veterans range from 50,000 to 100,000 6 to 11 times the non-Vietnam veteran population. Fact: Mortality studies show that 9,000 is a better estimate. "The CDC Vietnam Experience Study Mortality Assessment showed that during the first 5 years after discharge, deaths from suicide were 1.7 times more likely among Vietnam veterans than non-Vietnam veterans. After that initial post-service period, Vietnam veterans were no more likely to die from suicide than non-Vietnam veterans. In fact, after the 5-year post-service period, the rate of suicides is less in the Vietnam veterans' group.
- #3 .Myth: Common belief is that a disproportionate number of blacks were killed in the Vietnam War. Fact: 86% of the men who died in Vietnam were Caucasians, 12.5% were black, 1.2% were other races. Sociologists Charles C. Moskos and John Sibley Butler, in their recently published book "All That We Can Be," said they analyzed the claim that blacks were used like cannon fodder during Vietnam "and can report definitely that this charge is untrue. Black fatalities amounted to 12 percent of all Americans killed in Southeast Asia, a figure proportional to the number of blacks in the U.S. population at the time, and slightly lower than the proportion of blacks in the Army at the close of the war."
- #4 Myth: Common belief is that the war was fought largely by the poor and uneducated. Fact: Servicemen who went to Vietnam from well-to-do areas had a slightly elevated risk of dying because they were more likely to be pilots or infantry officers. Vietnam Veterans were the best educated forces our nation had ever sent into combat. 79% had a high school education or better. Here are statistics from the Combat Area Casualty File (CACF) as of November 1993. The CACF is the basis for the Vietnam Veterans Memorial (The Wall): Average age of 58,148 killed in Vietnam was 23.11 years. (Although 58,169 names are in the Nov. 93 database, only 58,148 have both event date and birth date. Event date is used instead of declared dead date for some of those who were listed as missing in action) Deaths Average Age Total: 58,148, 23.11 years Enlisted: 50,274, 22.37 years Officers: 6,598, 28.43 years Warrants: 1,276,

#5 Myth: The common belief is the average age of an infantryman fighting in Vietnam was 19. Fact: Assuming KIAs accurately represented age groups serving in Vietnam, the average age of an infantryman (MOS 11B) serving in Vietnam to be 19 years old is a myth, it is actually 22. None of the enlisted grades have an average age of less than 20. The average man who fought in World War II was 26 years of age.

#6 Myth: The Common belief is that the domino theory was proved false. Fact: The domino theory was accurate. The ASEAN (Association of Southeast Asian Nations) countries, Philippines, Indonesia, Malaysia, Singapore, and Thailand stayed free of Communism because of the U.S. commitment to Vietnam. The Indonesians threw the Soviets out in 1966 because of America's commitment in Vietnam. Without that commitment, Communism would have swept all the way to the Malacca Straits that is south of Singapore and of great strategic importance to the free world. If you ask people who live in these countries that won the war in Vietnam, they have a different opinion from the American news media. The Vietnam War was the turning point for Communism.

#7 Myth: The common belief is that the fighting in Vietnam was not as intense as in World War II. Fact: The average infantryman in the South Pacific during World War II saw about 40 days of combat in four years. The average infantryman in Vietnam saw about 240 days of combat in one year thanks to the mobility of the helicopter. One out of every 10 Americans who served in Vietnam was a casualty. 58,148 were killed and 304,000 wounded out of 2.7 million who served. Although the percent that died is similar to other wars, amputations or crippling wounds were 300 percent higher than in World War II .....75,000 Vietnam veterans are severely disabled. MEDEVAC helicopters flew nearly 500,000 missions. Over 900,000 patients were airlifted (nearly half were American). The average time lapse between wounding to hospitalization was less than one hour. As a result, less than one percent of all Americans wounded, who survived the first 24 hours, died. The helicopter provided unprecedented mobility. Without the helicopter it would have taken three times as many troops to secure the 800 mile border with Cambodia and Laos (the politicians thought the Geneva Conventions of 1954 and the Geneva Accords or 1962 would secure the border).

#8 Myth: Kim Phuc, the little nine year old Vietnamese girl running naked from the napalm strike near Trang Bang on 8 June 1972.....shown a million times on American television....was burned by Americans bombing Trang Bang. The incident in the photo took place on the second day of a three day battle between the North Vietnamese Army (NVA) who occupied the village of Trang Bang and the ARVN (Army of the Republic of Vietnam) who were trying to force the NVA out of the village. Recent reports in the news media that an American commander ordered the air strike that burned Kim Phuc are>incorrect. There were no Americans involved in any capacity. "We (Americans) had nothing to do with controlling VNAF," according to >Lieutenant General (Ret) James F. Hollingsworth, the Commanding General of TRAC at that time. Also, it has been incorrectly reported that two of Kim Phuc's brothers were killed in this incident. They were Kim's cousins not her brothers.

#9 Myth: The United States lost the war in Vietnam . Fact: The American military was not defeated in Vietnam . The American military did not lose a battle of any consequence. From a military standpoint, it was almost an unprecedented performance. General Westmoreland quoting Douglas Pike, a professor at the University of California , Berkley a major military defeat for the VC and NVA. The last American troops departed in their entirety 29 March 1973. FACT: How could we lose a war we had already stopped fighting? We fought to an agreed stalemate. The peace settlement was signed in Paris on

- \* It called for release of all U.S. prisoners, withdrawal of U.S. forces, limitation of both sides' forces inside South Vietnam and a commitment to peaceful reunification.
- \*The 140,000 evacuees in April 1975 during the fall of Saigon consisted almost entirely of civilians and Vietnamese military, NOT American military running for their lives.
- \*There were almost twice as many casualties in Southeast Asia (primarily Cambodia) the first two years after the fall of Saigon in 1975 then there were during the ten years the U.S. was involved in Vietnam.
- \*Thanks for the perceived loss and the countless assassinations and torture visited upon Vietnamese, Laotians, and Cambodians goes mainly to the American media and their undying support-by-misrepresentation of the anti-War movement in the United States.

What can cause a cut on my penis?

You have recently been notified that the Board of Veterans' Appeals (BVA) has made a decision in your case. If you disagree with all or part of the decision, you have two options. One of these is to appeal to the United States Court of Appeals for Veterans Claims (CAVC). You must appeal within 120 days of the BVA decision date to preserve your rights and your effective date. The other option is to file a supplemental claim at VA with new and relevant evidence on any disputed issue(s). You must do this within 1 year of the BVA decision date to preserve your rights and your effective date.

DAV routinely uses the firm of Chisholm Chisholm & Kilpatrick Ltd (CCK) to facilitate prompt review of BVA decisions. CCK has concluded that BVA may have erred in denying your appeal, or in failing to grant you the highest possible rating or earliest effective date. Through a special arrangement with DAV, CCK is willing to represent you at CAVC for no charge. (CAVC itself will require that you pay a nominal filing fee, although this fee may be waived based on hardship). Very few cases qualify for this special DAV program. If you are interested in taking advantage of this opportunity, please call Robert Chisholm and his firm as soon as possible at 844-823-0384. If you wait until the last minute, there may be insufficient time to prepare the necessary papers and you may lose your rights.

CCK's offer may not involve all of the issues you would like to dispute. For any remaining issues, you have the rights that I explained in the first paragraph. To the extent that you wish to file a supplemental claim, DAV is here, ready to assist you. Just contact your local National Service Office to get the ball rolling. DAV does NOT file appeals at CAVC.

Please remember that the decision to file any kind of appeal, whether at CAVC or VA, is yours and yours alone. Neither DAV nor CCK will make any filing without your express authorization. In addition, you are responsible for observing the deadlines we have explained. It is important that you read carefully all notices that you receive from VA about your appeal rights. Many aspects of the rules governing appeals are in a state of transition, and it is VA's responsibility to inform you of all the options available to you.

DAV is pleased that it can offer you the best in representation, whether at VA or, as here, through CCK at CAVC. If you have any questions about this letter, Mr. Chisholm's firm will be delighted to address your concerns. Just give him a call.

#### The Fifth Infantry Division: Its Long-term Contribution to the Army

#### Donald L. Cummings

#### Introduction

There are many excellent books about each of the services in every conflict focusing on many subjects and individuals. I published *Steel Tigers: The 77th Armor Regiment 1940-1992* in June 2024. I chose to use an Army armor regiment to examine US domestic and foreign policies through five levels of analysis from the national political leadership down to the soldiers on the ground who put the faces on these policies along with US values, attitudes, and beliefs to the civilian populations where they serve. Nothing happens in a vacuum, and my challenge was how to tell the story.

The 5<sup>th</sup> Infantry Division arrived in France on May 1, 1918 nearly 4 years after the war began. During the War, the overwhelming number of casualties caused by the trench warfare on the western front demanded a solution be found to restore mobility and maneuver to defeat an enemy. Using newly developed aircraft equipped for combat, and then inventing and employing the tank, the World War 1 visionaries saw a combined arms force of tanks and infantry breaking through an enemy's front defensive positions before it could conduct an orderly withdrawal and then advance rapidly into the enemy's rear or flank to exploit success before a counterattack could be organized. The evolution of aircraft added the third dimension to the battlefield.

The Red Devils with its attached 735<sup>th</sup> and 737<sup>th</sup> tank battalions in World War II and the Korean War with its tanks demonstrated the successes of the inventions. One issue that affects all armed forces over the ages including these two wars has been improving the capability of logistical units to keep apace with the maneuvering units.

#### The 5<sup>th</sup> Infantry Division

My emphasis in this article is the 5<sup>th</sup> Infantry Division after it was reactivated at Fort Carson, Colorado in 1962. The division became a major command in the US Strategic Reserve. In addition to preparing to respond to a Warsaw Pact attack in Europe, it prepared to help restore order in the United States during periods of labor strife and the civil rights movement. Federal troops were ordered to Little Rock, Arkansas in 1957 to assist local authorities respond to the integration of its public schools Civil disorder increased during the 1960s when troops were sent to Los Angeles, CA, Newark, NJ, Detroit, MI, and Washington, D.C. The Army's plan called for each Army area in the United States to designate and train 21,000 soldiers for restoring order within its area of interest in the following phases: immediate response, follow-on, and full brigade deployment

within 24 hours of the request for military assistance. Fifteen US cities were designated priority one and 105 smaller population centers were assigned priorities two through four,

The August 4, 1968 assassination of Dr. Martin Luther King at about 6 pm caused violence to erupt almost immediately across the nation in 130 population centers. The Fifth Division's 2d Brigade deployed according to the plan to Washington, DC, The 3<sup>rd</sup> Brigade was ordered initially to Cleveland, Ohio, but then diverted to Chicago, Illinois. The 1<sup>st</sup> Brigade was in its training program prior to deployment to Vietnam. It was ordered back to garrison, to fill the two brigades with troops to bring them up to strength. It also began crowd control training to prepare for the spread of the rioting to another city. The USAF had transports on the ground, but the violence began subsiding and the 1<sup>st</sup> Brigade never left Fort Carson. The deployed brigades were released back to Fort Carson by the middle of April when local authorities regained the capability to protect their populations and properties. Upon their return to Fort Carson, the 1<sup>st</sup> Brigade's soldiers returned to their units to continue training for deployment in July. The research for this portion of the book was very illuminating.

1st Brigade, 5th Infantry Division (Mechanized)

This article's primary concentration is the 1968 organization of the 1st Brigade, 5th Infantry Division when it was identified to deploy to South Vietnam. This topic opened a new chapter in the rich history of the Red Devils and the US Army that has continued for nearly two decades.

The first step taken occurred before 1968. It was implementing the Reorganization Objectives of the Army Division (ROAD) force structure introduced by President Kennedy in 1961 as a part of the Flexible Response strategy. This strategy was designed to enable the US avoid using military force in a potential confrontation that would credibly deter any enemy from employing a symmetrical or asymmetrical small-to-large military force that threatened destabilizing the international order.

The first Army division to use the ROAD structure was the 1<sup>st</sup> Armored Division. The 5<sup>th</sup> Infantry Division ROAD at Fort Carson was first ROAD infantry division. Both divisions made the change in February 1965 This concept was based on building blocks. There was a division headquarters group with one commander and two assistant division commanders and the combat support and combat service support entities necessary to support the infantry, mechanized infantry, and tank battalion blocks. The mix of battalions in a ROAD division varied with the mission assigned to it. Intermediate brigade commanders and their headquarters units each controlled a set number of maneuver battalion building blocks.

Following the 1968 Lunar New Year Offensive (Tet), General Westmoreland, the theater commander, requested an additional 206,000 troops be sent to South Vietnam within six months. The President did not approve the 206,000, but he did authorize 15,500 more in two separate brigades, one of which was the 5<sup>th</sup> Infantry Division's First Brigade with its tanks, infantry, and mechanized infantry battalions. Until 1968, Westmoreland, originally an artillery officer, did not believe the terrain would permit tracked vehicles to realize their potential.

The maneuver unit building blocks of 1st Brigade, 5th Infantry Division (Mechanized) included the 1st Battalion 11th Infantry, 1st Battalion 61st Infantry (Mechanized), and the 1st Battalion 77th Armor. The other combat, combat support and combat service support units were the 5th Battalion 4th Artillery (155 millimeter) (Self-Propelled), A Troop, 4th Squadron 12th Cavalry, 75th Support Battalion, Company A, 7th

Engineer Battalion, 532<sup>nd</sup> Signal Platoon (Forward Area), 1<sup>st</sup> Detachment 5<sup>th</sup> Military Intelligence Detachment, 86<sup>th</sup> Chemical Detachment, 48<sup>th</sup> Public Information Detachment, and the 407<sup>th</sup> Radio Research Detachment. Finally, there was an aviation section with four UH-1H multipurpose and four OH-A6 light observation helicopters. There was a brigade commander, deputy brigade commander for operations and intelligence, and brigade executive officer who directed the brigade staff. Once the brigade was in Vietnam, modifications occurred as required.

The force structure of the 1<sup>st</sup> Brigade 5<sup>th</sup> Infantry Division (Mechanized) was the precursor to today's Brigade Combat Team (BCT). The mechanized infantry and tank battalions organized into task forces. The mechanized infantry battalion had two mechanized infantry companies and one tank company and vice versa for the tank battalion. The two task forces trained at Fort Carson as individual battalions. Tankers and infantrymen interacted and each learned the other's personal strengths and weaknesses and the capabilities and limitations of their equipment. Once in Vietnam, armor and infantry companies were cross-attached according to the mission.

The Army shifted in 2006 from a division-based force structure which included all of the assets to be the basic deployable mix of units enabling independent operations to one where the building blocks of the BCT enabled assumption that role.

General Westmoreland placed the Red Devils just below the Demiltarized Zone in northern Quang Tri Province under the command of the US Army's XXIV Corps in Phu Bai. but under the operational control of the 3<sup>rd</sup> Marine Division at Quang Tri Combat Base. Westmoreland had wanted to locate a major unit in this area earlier, but was unable to because of more pressing tactical demands.

The Brigade's headquarters shared the base with the Marines in a section named Camp Red Devil. The Brigade flew from Fort Carson to the Quang Tri Airfield where multiple models of military aircraft were located. Each planeload soldiers went through in-processing steps, and then moved by truck to the logistical base at Wunder Beach where the units acclimatized to the heat and humidity, drew their equipment, test-fired their weapons, and then deployed to their assigned firebases. The 1/11 Infantry took control of A-4 (Con Thien) from a USMC battalion. This base was within the range of North Vietnamese artillery across the Military Demarcation Line which was the Ben Hai river that separated North and South Vietnam. A short distance south of A-4 was C-2 and C-2 Water Point where the 1/61 Infantry (Mech) was located. The main east-west highway between the Laotian border and the city of Dong Ha was Highway 9 (QL-9). The main north-south highway from Hanoi to Da Nang was Highway 1 (QL-1) where a bridge crossed the Cua Viet River. The last US base above QL-9 was transferred from the Marines to the 1/77 Armor. It had two parts: C-3 and C3 Bridge at another Cua Viet River crossing point. One tank company and the Scout Platoon secured this location. This series of bases occupied by the maneuver battalions was nicknamed Leatherneck Square. Once the transfer of the real estate between the Marines and Red Devils was completed, the entire brigade was operational.

During the initial weeks, the US and North Vietnamese Army (NVA) had to learn about their opposition. The latter always looked into the air for Marine and Army infantry approaching in helicopters. The Red Devil maneuver battalions moved on the ground. Two early operations are an example. The 1/77 Armor with two tank companies and one B-1/61(M) company attacked into the Demilitarized Zone close to the Ben Hai River. The commander stopped his tank atop an enemy position so no one could escape and he could focus on his intended targets. The second operation saw the 1/61 Inf (M) task force with one B-1/77 tank company attack a large NVA formation infiltrating into South Vietnam. The enemy had crossed the Ben Hai River. The 1/61 Inf (M) task force was between the NVA and the Ben Hai and attacked the enemy's rear surprising them. A major battle occurred.

The Red Devils had to learn about enemy mines, booby traps, and that ensuring the security of night defensive positions required a serious effort with great attention to detail. The enemy always looked for weaknesses in targets they selected so they could exploit them even if it took hours of undetected observation before they initiated their attacks.

The 1st Brigade served in South Vietnam from July 1968 to August 1971. Units performed varied missions. Food denial stopped the transport of food from the populated region of Quang Tri to the Base Areas near the Laotian border. Cordons and searches of villages to demonstrate to the people that the central government could provide services and protect them. This included providing the citizens with medical and dental treatment, and other services including village construction projects. Another mission was reopening roads through abandoned villages so that ground forces could traverse the routes keeping the NVA off balance.

Two large-scale operations included returning to the Khe Sanh plateau in when intelligence indicated that reconstituted NVA units were moving back into South Vietnam following their defeats during Tet 1968 and the assault on the Marines at Khe Sanh Compat Base. The first set of operations in 1969 were nicknamed *Operation Remagen* and *UTAH MESA*. Remagen consisted of two increments. The first was controlled by the 1/77 Armor and the second by the 1/61 Infantry (M). The first was a reconnaissance—inforce, and the second was to follow portions of the Ho Chi Minh Trail without being observed by the NVA in the mountains across the river separating Laos and South Vietnam. It is enough here to state that the route along QL-9 had to be completely reconstructed so the tracked vehicles could reach the plateau. UTAH MESA was the second increment and it included the 1/61 (M), a USMC regiment and two battalions from the 2<sup>nd</sup> Army of Vietnam (ARVN) Regiment, 1<sup>st</sup> ARVN Division.

All three operations on the plateau were resupplied completely by air. Only tracked vehicles ascended the plateau. The logistical support included all classes of supply and major maintenance such as replacing engines, transmissions, and track were performed on the plateau. The results proved that mechanized units could perform any assigned mission.

The second major operation was *Operation Dewey Canyon II – Lam Son 719* beginning in January 1971 and ending in April. The purpose of the enterprise was to allow the ARVN to cross into Laos and attack NVA safe havens. Dewey Canyon II was to reopen QL-9 up to the Khe Sanh plateau permitting access by wheeled vehicles as well as tracked. and to secure QL-9 to the Laotian border. Lam Son 719 was the ARVN attack into Laos. No US troops including US advisors to the ARVN could cross the border.

Operation Keystone Oriole (BRAVO) was the notification that the Red Devils were to leave Vietnam. The order to stand down and prepare to leave Vietnam arrived on June 12, 1971. The Brigade's staff formulated a phased plan to be initiated beginning July 1<sup>st</sup>. Areas of operation had to be turned over to the Vietnamese and remaining US units. All equipment, records, and funds had to be accounted for and turned in by set dates. Vehicles had to be taken to Da Nang with tracked vehicles transported by sea and wheeled vehicles traveling in convoys. Personnel were processed out at Quang Tri. Each battalion had a deadline to reach zero strength.

The 1st Brigade 5<sup>th</sup> Infantry Division (Mechanized) returned to the United States according to the plan. Its colors were cased and returned to Fort Carson where it was deactivated on August 22, 1971. The 4<sup>th</sup> Infantry Division replaced the deactivated 5<sup>th</sup> Infantry Division at Fort Carson in 1970.

# Veterans benefits \*\*\* increase 2.5% in 2025



The adjustment is close to the average increase of 2.6% for the past decade

n Oct. 9, 2024, the Social Security Administration announced a 2.5% boost in the cost-of-living adjustment (COLA), the smallest in the last three years.

The Department of Labor determines the annual COLA by measuring the Consumer Price Index (CPI). The CPI is based on a broad sampling of the costs of consumer goods and expenses.

Veterans, families and dependents eligible for VA benefits saw the new amount reflected in their monthly checks effective Jan. 1. The increase affects everything from Department of Veterans Affairs disability compensation to clothing allowances to Dependency and Indemnity Compensation and survivors benefits.

"Many veterans and their families rely on their VA benefits to help cover essential expenses like food, housing and utilities," said DAV Washington Headquarters Executive Director Randy Reese. "The rising costs of consumer goods and other expenses the last several years have put a significant strain on veterans and their families, and the cost-of-living adjustment is intended to help counteract the impact inflation has on veterans benefits."

The 2.5% increase for 2025 is well below the 3.2% in 2023, 8.7% in 2022 and 5.9% in 2021. However, this boost is still close to the average increase of about 2.6% for the past decade.

The 2025 adjustment means VA disability checks will go up about \$4.28 per month for those with a 10% rating and \$93.45 for those rated at 100% who don't have dependents.

## Free Dental for Veterans and Spouses Everyone for Veterans

To meet E4V's threshold for care, a veteran must have served for at least two years, be honorably discharged, show proof of financial hardship, and be less than 100% service-connected disabled. Along with filling out the application form, a veteran also must submit their DD214 paperwork, a VA disability award letter from this year (even if they are rated at 0%), and, if a veteran's spouse is applying, a marriage certificate.

If accepted, the process of linking a veteran to a dentist in their area begins. E4V does not manage urgent dental cases, but it can help address bridges, crowns, dentures, fillings, implants, and root canals, et al. Since 2008, nearly 900 veterans and their spouses have had their oral issues through the efforts of Cheng and then E4V.

In all, 654 dentists nationwide have volunteered with E4V, the organization's data shows.

Because of an influx of applications that must be vetted and a limited network of volunteer dentists -- there might not be one near where a veteran lives, for example -- vets who turn to E4V should prepare for a potentially long wait. While Cheng said the average time it takes to connect a vet to a dentist is a few months, the organization's website warns that lag could run for two years.




